1. Council to discuss and approve tax rate for upcoming year 2024. Take action: Council members discussed options for the 2024 tax rate. After discussion Terry made a motion to approve the 23-25 budget as presented. Johnny Hubbard seconded the motion. Vote taken. All approved with none opposed. Motion carried.

Take action: Jada made a motion to approve Resolution 186, changing the signatories. Mary Seconded the motion. Vote taken. All approved with none opposed. Motion carried.
